1 EDITORIAL

EDITORIAL

Dear Reader,

it is our pleasure to present the 2004 edition of our Institute Report to our advisory board, our international partners, the faculties that jointly sponsor our institute in the university as well as all interested parties.

The release of this report coincides with our 8th annual 'East Asia Day' on which we celebrate this year the 10th anniversary of the Institute of East Asian Studies at the University of Duisburg (now Duisburg-Essen). We are proud to have recruited Dr.Theo Sommer, (editor-at-large of *Die Zeit*) as keynote speaker for this event. Dr. Sommer will speak on 'Regional Security in East Asia'.

Looking back over ten years of research and teaching on contemporary developments in East Asia at the Institute of East Asian Studies, it may be stated that the Institute has come a long way. Because of the particular model of East Asian Studies, combining rigid disciplinary exercise with the in-depth regional study of East Asia, the Institute succeeded first in 1997 in filling all six chairs in East Asian Studies. Today, with more than 30 scientists employed, we are the largest Institute of contemporary East Asian Studies at a German University. In these ten years our researchers have published appr. 1000 books, articles, papers, reviews and contributions to newspapers, many of these peer-reviewed. In the year 2001 we established a joint research program focused on 'Stability and Change in East Asia' with 6 individual projects, all funded by the German Research Foundation (DFG). Altogether, 20 funded research projects are currently being carried out at the institute and / or in cooperation with institute members.

Three different study programs on East Asia are currently being offered by the institute, among which the five year diploma program East Asian Studies (Diplomstudiengang Ostasienwissenschaften) is the largest. This winter semester a total of 121 students have started in this program – 65 % more than in the previous year. We are very pleased and honoured that in 2004 the university acknowledged the high standard of teaching at the institute by awarding a prize for outstanding teaching achievements to institute member PD Dr. Claudia Derichs.

The research activities of the institute over this past year have been dominated by the joint research program on 'Stability and Change in East Asia'. In addition various other research projects have commenced, covering a broad range of topics, some of primarily theoretical interest, others tackling problems of practical political and / or economic relevance. This mixture of research agendas reflects the overall self-understanding of the Institute as rooted in sound theoretical approaches while at the same time, concerned with praxis-oriented problems of the relationship between the European – East Asian regions.

The Institute of East Asian Studies strives to promote and train a new generation of young professionals and scholars. We are pleased to announce that Dr. Claudia Derichs very successfully completed an habilitation project and received the *venia legendi* for comparative and international politics.

The successful work at the Institute has also been reflected in the interest of other organizations and institutes in its staff. In the reporting year 2003/2004 Florian Coulmas (Chair: Japanese Language, History and Culture) as well as Karen Shire (Chair:

Sociology – Japan) received calls to join academic organizations outside Duisburg. Florian Coulmas has in the meantime accepted the invitation to join the German Institute of Japanese Studies (DIJ) in Tokyo, Japan, as its new director. He is now on leave from his duties at the University of Duisburg-Essen and will return to the Institute of East Asian Studies in 2009. We are honoured that the renowned socio-linguist, Prof. J.V. Neustupny of Monash University in Australia has accepted our offer to represent the chair of Florian Coulmas for the winter term 2004 / 2005. Karen Shire received a call for the C4 chair for 'Modern Japanese Studies' at the University of Düsseldorf which she has been representing from April 2004 to March 2005. Her duties in Duisburg were taken over by Dr. Wolfram Manzenreiter (University of Vienna) from April to September 2004 and, currently in the winter term 2004 / 2005, by Dr. Akira Takenaka who had previously represented the chair of Japanese Politics and Economy at the Free University of Berlin.

All activities in the reporting year have been overshadowed by the long process of integrating the two campi Duisburg and Essen into one, truly integrated university. At the time of the final editing of this report, this process has still not been finalized, resulting in some intransparency and insecurity regarding the future development perspectives of the Institute of East Asian Studies in Duisburg. Seen in combination with the dramatic cuts which university budgets are facing all over the country, the external environment for the further development of the Institute may deteriorate in future. The pressure on the Institute to attract additional funds from outside the university budget is rising substantially. Inter-organizational competition and the need to create 'marketable' research results is finally becoming a reality. We have been working hard to prepare the Institute of East Asian Studies for this challenge and are confident that we will be able present some first results in next years issue of the Institute Report.

Symbolizing the sharpened focus of our work in the context of a changing environment, at the occasion of its 10th anniversary, the Institute is launching a new logo, designed to highlight the bridging function of the institute between Europe and East Asia and to underline our focus on East Asian modernities.



In Spring 2004 all scientists of the Institute have moved from the old "villa" and many other locations scattered on the campus in Duisburg to a new location in the 6th and 7th floor of old office building (LE) formerly hosting the rectorate. For the first time all 40 employees work in the same building. We are confident that this concentration will further improve the cooperation among us and result in a gain of the quality in research and teaching.

The pages which follow offer a detailed account of the activities of the Institute for East Asian Studies during the academic year October 2003 September 2004. Once again it is a pleasure to acknowledge financial support by a number of funding agencies. Thanks are due to:

4 RESEARCH ACTIVITIES **FORSCHUNGSAKTIVITÄTEN**

4.1. Joint Research Activities / Gemeinsame Forschungsprojekte

Joint research project on stability and change in East Asia

In 2001 our joint research program was accepted for funding by the DFG. The research program of the institute includes six funded projects, all of which got underway in 2002. A first joint publication appeared as a special issue of the journal ASEAN (Nr. 84, July 2002). All the empirical projects are nearing completion and first results have been published (cf. list of publications). The final reports are due in 2005.

Florian Coulmas:

Multilingualism in Japan

This project examines the special situation of growing linguistic heterogeneity in a society traditionally operating under monolingual assumptions. The focus of study will be Tokyo as the place where the new multilingualism has become most salient. Concretely, the two dissertation projects concentrate on two complementary fields:

- (1) The linguistic infrastructure provided for those parts of the population with little or no proficiency in Japanese
- (2) The attitudes of the host community towards the growing presence of foreign languages within the city

Doris Fischer

Stability and Commercial Information - The economic relevance of institutional design within the information system

Stability and information are concepts with a prominent place in economics literature. The use of both concepts in a theoretical context is however, rare. It is the purpose of this research project to analyse the relationship between stability, information and economic performance, thus describing a new research programme. The project aims at analysing how institutions and institutional change within the information system matter for economic performance and stability. As the Chinese government is constantly stressing the importance of stability while the Chinese information system is currently in a process of institutional transformation, China is supposed to be a valuable starting point to demonstrate and explain the impact of the information system on economic performance and stability.

Japan's Construction Lobby Activities and Their Spatial Impact – Systemic Stability and Sustainable Regional Development

“Japan, Inc.”, “construction lobby” and “sustainability” are the keywords of this research project in the field of economic and political geography. Its aim is to apply institutional theory to the problem of the stability of the “system Japan” with regard to sustainable regional development. It will assess this question empirically at several spatial levels of scale – national, regional and local. The focus is on the “Iron Triangle”, the interplay of ministerial bureaucracy, politics and big business that is the

model of the “system Japan” and has long been a symbol of the country’s economic prosperity. It has also long since become a symbol of the inefficiency of the system. In the face of structural reform measures, unmastered crises and the globalisation induced pressure to adapt, the stability of the system appears doubtful. The “Iron Triangle” is exemplified by the construction industry and its lobbying activities. In this connection we hypothesise that though the “system Japan” is quite fragile, as has been quite correctly confirmed in various regards, it still definitely does function in the case of problem-laden branches of industry. This holds particularly for the construction industry, which embodies like no other branch the parallel interests and the informal alliances of the most important actors. The basis of its existence is “dangō” – cartel-like agreements among bidders in public construction commissions. This mode of deriving income exists all over the world, but it is especially profitable in Japan for the involved actors. The analysis first deals with their power and network structures within and outside of the “Iron Triangle” at the national level. The discussion of the stability of the system and its effect on “sustainable” regional development will then have to be related to the prefectoral and communal levels. Japanese construction lobby activities will be critically scrutinised with regard to conflicting “top-down” and “bottom-up” strategies – in the context of the general conditions, incentive structures, credibility and path dependency of the complex action systems and from the viewpoint of spatially relevant structures and processes.

Thomas Heberer (together with Prof. Dr. Gunter Schubert, Tübingen)

Is Local Democracy Paving the Way for political and Social Stability? Implementation and Political Effects of Village and Urban Inhabitants Elections in China

According to official Chinese statements the institution of direct village elections and recently elections of urban inhabitants committees is of significant importance for the programme of political reforms. It is declared to be part and parcel of “Socialism with Chinese characteristics”. Its aim is the consolidation of Party control among the local population. Yet, furthermore, there are obvious signs that this “local democracy” ordered by the political leadership tends to alter the existing order and strengthens the process of social pluralization and participation. We find distinct evidence of a political emancipation of the rural populace.

This research project attempts to identify the impact of rural and urban elections on political communication and political participation. It focuses on the changing attitudes of the local population and local cadres and their effect on China’s political system. It is carried through with colleagues of two Chinese partner institutes. Between 2002 and 2004 field surveys were conducted in three rural (Shenzhen, Jiangxi, Jilin) and three urban areas (Shenyang, Chongqing and Shenzhen).

Karen Shire:

Employment Diversification in Japan: The Case of Temporary Dispatched Work

From the perspective of the expansion of a new form of employment – temporary dispatched work – the research has aimed at conceptualizing change in the Japanese employment system. The project received a third year of funding from Jan. 1, 2003 and has since focussed on two activities: matching the completed study of temporary work reregulation in Japan with a study of the same in Germany and the conception and implementation of a mail survey of a sample of Japanese temporary help firms. The findings so far point to similarities in the the weaker involvement of labour unions in the re-regulation process in Japan and Germany. In Japan, the role of the

Ministry of Health, Welfare and Labor advisory councils have been marginalised in favor of the role of the deregulatory commissions formed under the auspices of the cabinet office. This shift in the venue of policy making has weakened the participation of labor in key stages of the policy formation process. Likewise in Germany, the Hartz Kommission, where representatives of private sector firms overshadowed the participation of the social partners, operated in a way to minimize the influence of the German Ministry of Labor and labor representatives. A major difference is however, the continued role of the social partners in Germany in implementing the Hartz measures concerning temporary work.

Further research in Japan has focussed on the marketisation of inter-firm relations, which we argue underlies the expansion of temporary help firms and temporary agency employment since deregulation. Four new reports of research were completed in 2003: a discussion paper by Jun Imai, published by the Institute of East Asian Studies, a discussion paper by Katrin Vitols, forthcoming in the Duisburger Beiträge published by the Institute of Sociology, a peer reviewed journal article by Katrin Vitols forthcoming in 2005 and a book chapter by Imai and Shire, also forthcoming in 2005. A complete draft of the dissertation manuscript of Jun Imai was completed in the summer of 2003. Uwe Holtschneider, a work-study student in the project, is utilising the project data for his Diplomarbeit in the Faculty of Economics. The researchers are currently preparing a book manuscript reporting the comparative results.

Markus Taube

Stability in Instability. China's TVEs and the Evolution of Property Rights

For two decades economic and social stability in China's rural areas has been based on the successful evolution of township village enterprises. These enterprises, however, feature a property rights structure which according to conventional property rights theory should make these enterprises highly inefficient and prone to quick dissolution. But as closer analysis indicates, exactly these ambiguous property rights structures may be the recipe for success. They constitute highly flexible best practice solutions for corporate survival in the context of rapidly changing environments in a transition economy. But as the Chinese market economy matures, these ambiguous property rights structures will nevertheless have to make way for clearly defined – stable – property rights structures.

4.2. Other current and completed research projects / Andere laufende und abgeschlossene Projekte

Helmut Demes:

Education, Vocational Training and Employment in International Comparative Perspective: Japan – China – Germany (funded by the Japanese Society for the Promotion of Science, 2001-2004)

New developments in vocational training and education are being studied in this international project carried out in collaboration with Japanese, Chinese and German researchers. The project focuses on changes (in organization and content) of education and vocational training policies in response to the ongoing globalization of economies, changes in employment structures and labour markets, as well as new qualification and skill requirements of companies. Among others the following topics are analysed in an international comparison of China, Japan and Germany:

- responses in education and vocational training to globalization
- new developments in the relationships between education, vocational training and employment
- selection and allocation mechanism of the education system and changes in educational participation of young people
- new tendencies in the labour market for new school graduates.

Cooperation Partners: Nagoya University, East China Normal University, Hagen University, Duisburg-Essen University.

Claudia Derichs and Mark R. Thompson (current):

Dynasties and female political leadership in Asia (funded by DFG)

The project addresses the striking fact that many governments or opposition movements in Northeast, Southeast, and South Asia have been, or are led by women. Given the fact that these countries are widely considered patriarchal and paternalistic in character and that male competitors have been around to challenge the women's ascendancy to a political position, makes the phenomenon even more interesting. Women in Asia lead governments and opposition movements independent of levels of economic development, cultural differences, and types of political systems. Most surprising – given widespread stereotypes about Islam – is female leadership in the heavily Muslim states in Southeast and South Asia. There is no doubt that the rise of female leaders is linked to their being members of prominent families. What is less usual is women being the beneficiaries of their family's political inheritance – it is not just a "shortage" of men that leads women to be selected as successors within the family. In addition to the question "why women leaders" this project will consider what the results of this study can add to discussions of the concepts of gender, development, and democratization.

Winfried Flüchter

Public Housing and Urban Development in Singapore – Ethnic Groups Between Residential Segregation and Residential Integration (funded by DFG: German Research Council, Jan. 2001 – Dec. 2004)

Public housing is regarded as one of the "pillars of the nation" when it comes to the integration of Singapore's multi-ethnic population. By means of a well-contrived system for providing for their old age, almost 90% of the inhabitants have become quasi-owners. The research project focuses at the micro-level on the degree of equilibrium and particularly the acceptance of the mixture of social and ethnic population that is consciously favoured by Singapore's government. Of late it has frequently been questioned, not only in Singapore, whether under certain conditions segregation would not be a (better?) alternative. With this question in mind we will evaluate Singapore's strategy ("social and spatial engineering"). The discussion of the advantages and disadvantages of a balanced mixture and of segregation at the micro-level needs to be related to the macro-level. For the self-image of the "developmental state" of Singapore, public housing is of crucial importance as a sign of "nation building". The links between priorities at the macro-level and modes of behaviour at the micro-level will be analysed. This project in the field of urban and political geography is based on a critical/hermeneutical concept of science and will apply approaches from decision and behavioural theory, with particular attention to the ethnic-cultural approach. Research fellow in the project is Dipl.-Geogr. Ulrich Zur-Lienen.

Japan: Rice Farming and the Rice Market Between Globalization, Ideology and Sustainability

Since the Uruguay Round of the GATT (1986-93) Japan has been under pressure to open its rice market. This is an enormous challenge for Japan's "rice culture." Rice has extraordinary symbolic power in Japan. It is considered an almost sacred phenomenon, the "backbone of the nation," deeply embedded in the cultural landscape, history, society, economy and politics of the island empire. How are the Japanese responding to this challenge? What arguments are they advancing? How should these be assessed from the standpoint of trade liberalization, ideology, structural problems in agriculture and the principles of sustainability? What role do vested interests and cultural factors play?

Thomas Heberer

Discourses on Political Reform and Democratization in East and Southeast Asia in the Light of New Processes of Regional Community-Building (funded by Deutsche Forschungsgemeinschaft, 2000-2003)

Beyond the purely economic dimension of the financial and economic crisis in Asia there is also a political dimension which has generated a discourse on the political reasons for the crisis and thus the future of political structures and political systems. Albeit that the discussion may take different turns in each of the countries involved, emerging transnational processes and discussion contexts can still be discerned.

This project intended to:

- trace and analyze the conceptions on the political future since the mid-nineties at three levels: 1) the political elite; 2) the intellectual elite; 3) NGOs;
- look at the influence exerted on the political reform process by political discourse;
- discern whether a second debate on "Asian values" is emerging or has emerged on the basis of democratic values;
- analyze whether the conceptions formed by political discourse tend to be "Asian", "Western" or syncretic;
- provide an exhaustive answer to the question whether political discourse is contributing to a debate reaching beyond the earlier one on "Asian values" and whether a common identity oriented towards democratic elements is formed.

This was analyzed in the case of two authoritarian states (China, Vietnam), a multi-ethnic, formally democratic state with strong authoritarian features (Malaysia), and a democratic state with significant parochial structures and patterns of behavior (Japan).

The following questions were examined and analyzed:

1. Which conceptions regarding the political future were discussed since 1990? How had the Asian crisis affected the character of the debate and which levels of discussion and changes in perspectives could be discerned? We were particularly interested in: a) ideas for a future political system such as concepts of democracy, ideas concerning the political order, forms of participation; b) How were events leading to the crisis viewed? Where and when did we see a recognition of faults, and where was the status quo of political-systemic and structural relations defended? c) Which reform concepts were introduced and discussed? Which ideas, principles, val-

ues and traditions did political actors rely on? c) Were there any attempts at long-term democratization, and if so, which forms of democracy were regarded as emulative?

2. This was analyzed at three levels: a) the political elite (both governing and non-governing); b) NGOs, with a distinction between external and internal spheres of influence, i.e. foreign and domestic impulses; and c) the intellectual elite.

3. Was there any link between the level of political discourse and the change in political structures (such as the emphasis on village and communal elections in China and Vietnam)? Can we expect a form of "intellectual mobilization" (Bendix)?

4. Were there any signs of an emergence of a second Asian values debate on the basis of democracy-oriented values? Did this lead to an application of Western democratic concepts or were there any efforts to draw a boundary between those concepts and syncretic indigenous conceptions?

5. Are these "Asian" concepts truly Asian in the sense that there are democracy-inducing concepts and factors drawing on a reservoir of indigenous elements which can be viewed as local thought products deviating from Western ideas? Within this context, we understand "indigenous concepts" to mean ideas on political change born within the respective cultural realm which need not necessarily be compatible with Western ideas. We do not subscribe to a homogenous notion of culture in this context, but rather to different cultural traditions that may produce competing concepts and contending theories.

6. Did the discourse on democratization and participation contribute to a discourse beyond the earlier debate on values within the region, and is it possible to, on the basis of the mentioned synthesis debate, ascertain new signs of a common regional identity more decidedly marked by elements of democracy?

Ethnic Entrepreneurs between Market Behaviour and Social Morality. The Impact of Ethnic Entrepreneurship on Social Change and Ethnicity. A Case Study Among the Yi in Liangshan Yi Autonomous Prefecture in China (funded by Volkswagen-Stiftung, 2000-2004)

Aspects of ethnic mobilisation during processes of modernisation have until now only marginally been investigated. In particular there are nearly no academic investigations or analyses of the development of a new entrepreneurship among indigenous minorities and its role in ethnic mobilisation and ethnic consciousness. In China, as a multinational state with 55 ethnic minorities, we have a good area for specific research, in particular seeing as there are very few investigations which deal with tensions between economic modernisation and social change among minorities. This is where our project started out, with four basic questions:

1. The role of new entrepreneurs for social change and social structural change in Yi society.

2. The development of a Yi ethnic entrepreneurship and its impact on social mobilisation.

3. The changing role of social organisations (lineage) and of economic thinking following economic and social change.

4. The relationship between entrepreneurship and ethnicity.

The double role of entrepreneurs as social actors in the market place on the one hand and as members of an ethnic group (Yi) on the other hand is an important interface for our investigation. Individuals (in our case entrepreneurs) operate simultaneously as individuals and as members of personal-relationship groups, like ethnic, regional or language groups. Such a double role can also be found in the ethnic entrepreneur. Here ethnic mobility goes along with individual mobility. An investigation of ethnic entrepreneurs as actors with not only individual but also of ethnic mobility contributes to a better understanding of the processes of change in the social structures.

The project was based on four dimensions of investigation:

1. The theoretical dimension: to investigate whether the development of an ethnic entrepreneurship among the Yi can be explained by existing theories about ethnic entrepreneurship, with the emphasis on the investigation of the link between economy (the contribution of the ethnic entrepreneurship to economic development) and society (the social function of entrepreneurship and its influence on social change in the society affected). Simultaneously the project researched the link between ethnic entrepreneurship, ethnic identity and ethnicity.

2. The comparative dimension: we investigated how Han and Yi entrepreneurs in the Liangshan Autonomous Region differ from one another. Central issues here were economic thinking, social behaviour, economic interconnection or segregation, mutual perceptions and ethnicity, and determinants of ethnic group differences in labour markets and in entrepreneurial roles. Only through comparison can one make significant statements about the complexes of ethnicity and ethnic identity.

3. The practical research dimension: as well as the theoretical and comparative aspects our results will have a practical application in the sense that they provide concrete, specific suggestions for the development of entrepreneurship among the Yi. (This was at the request of our Chinese partner institution, which has to legitimise its research and financial support through being geared to practical purposes.) This has to be seen as an added benefit to the project because theoretical and comparative results will be compacted into a context of practical orientation.

4. The methodological dimension: through empirical research and a transfer of social science theories and methods (in the form of quantitative and qualitative methods) we improved the research potential of our Chinese partner institute.

The project was carried out in co-operation with the Research Institute for Yi Studies of the Yi Liangshan Autonomous Prefecture in Xichang.

The following questions were investigated:

- To what extent are an ethnic economy and an "ethnic entrepreneurship" with strong network structures developing as a result of the reorganisation to (etatist) market economy structures?
- What role does the mobilisation of ethnic resources play for Yi entrepreneurs?
- To what extent do ethnic entrepreneurs benefit from their ethnic surroundings, and do they enjoy advantages due to ethnic solidarity which are denied non-Yi in the Liangshan region?

- What effects does the new Yi entrepreneurship have on Yi social structures (e.g. the lineage)?
- Does segregation increase, and is there a cultural division of labour between Yi and Han entrepreneurs? Are new ethnic tensions building up as a result of market competition and the growing possibility of being ousted from the market?
- To what extent do Yi and Han entrepreneurs differ in their entrepreneurial behaviour and economic thinking?

In the context of these questions which form the main thrust of the investigation, we also intended to establish whether, and if so to what extent, ethnic entrepreneurship strengthens ethnic identity and ethnicity.

Between 1999 and 2002 more than 150 entrepreneurs in ten counties were interviewed.

Wolfram Manzenreiter

Facing the World: Public, official and other versions of Japan at sport mega-events

Since the global spread of modern sports started in the 19th century, sport played a useful role in aiding and abetting state sponsored nationalism. Particularly since sport turned into a leading content for globalising media markets, sports mega-events, here conceptualised as “large-scale cultural (including commercial and sporting) events which have a dramatic character, mass popular appeal and international significance” (Roche 2000), were utilised by political elites for the double purpose of outward representation and inward unification. Yet the relationship of sport and nationalism is seldom straight forward and its nuances are only revealed when looking at sportive nationalism as “a complicated socio-political response to challenges and events, both sportive and non-sportive, that must be understood in terms of the varying national contexts in which it appears” (Hoberman, 1983). The assertion of the media joining hands with the ruling elite in actively steering the image of the nation cannot pass unchallenged, because of the sense of ambiguity about what the nation is. Drawing on media records, opinion polls and first-hand observation, the display of Japan on the occasion of international sport mega events (with reference to the 1964 Tokyo Olympics, the 1998 Nagano Winter Olympics and the 2002 FIFA World Cup) will be analysed as an outcome of negotiations between official versions of ‘Japan’ and counterdrafts by civil society stakeholders.

Wolfram Manzenreiter

Comparing Sports Policy, Sports Investment and Regional Development Initiatives in the Hosting of Major Sports Events in Asia and Europe

Hosting major international sports events can bring direct and significant sports benefits to the hosting nation. International sports events can also assist in the achieving of other objectives such as economic and social development. Furthermore hosting international sports events can provide a forum for the celebration of athletic, artistic and cultural excellence and provide citizens of hosting nations with the opportunity to contribute to the expression of their national identity. What is surprising is that with a handful of exceptions international sport in general and major sports events in particular have been widely neglected by Asian scholars. The primary purpose of the project therefore is to address this neglect in a substantive way by studying comparatively the economic, political and cultural significance of bids for, and the hosting of,

major sporting events. Amongst the questions that the project will seek to answer are: Why do governments and cities compete for the right to host major international sporting events? What are the trade-offs and opportunity costs of doing so? And, do such events ultimately deliver the benefits, economic and otherwise, that their proponents proclaim?

Werner Pascha, Ingo Meierhans

New Mechanisms of Economic Policy in Japan (funded by MEXT, JSPS et al., 2002 to 2006)

As the state in Japan is undergoing a major upheaval of public trust, fiscal limits of the state get tighter, civil society expands and as individual interests mature, the project looks at various (new) mechanisms to solve public policy issues. In terms of methods, institutional economics and political economy are employed. Pascha looks into the possibilities of setting up independent agencies for functions formerly supplied by the state. One instance is the central bank (Bank of Japan), which became more independent under a new BoJ Law in 1997/98. Another question is the independence of the judiciary, which received more attention recently due to the ongoing judicial reform process. On a more basic level, the project looks at whether a rule-of-law-regime is compatible with the traditional, more network-oriented approach of economic policy making in Japan. Meierhans takes up the issue of public-private-partnerships in Japan and asks why such mechanisms between the state and the market have become more prominent in recent years and to what extent they can be expected to deliver positive results. One concrete issue is to appraise the different organisational set-ups in health care: how do and how might hospitals under public management compare to other set-ups with a more pronounced involvement of private interests?

Intraregional and interregional economic relations in East Asia (financed by various organisations, since 2000)

Economic relations of Pacific Asia are studied from an institutional economic viewpoint. The rationality of various organisational mechanisms like APEC is analysed within a political economic framework. Conventional economics often concludes that regional or even trans-regional mechanisms are saturated with potential organisational failure issues. For instance, they are very much detached, through various layers of legislature and executive, from the final principal, the individual voter. Moreover, such mechanisms often tend to avoid binding agreements and thus cannot effectively control for shirking or even defection. From a different perspective, though, scholars based in the international relations literature often see such organisations in a more positive light. They frequently stress that such regimes constitute a process in which trust and more reliable commitments can slowly evolve. The project tries to take these latter considerations seriously and integrate such "evolutionary" issues into an analysis of the political economic mechanisms that define the intra- and inter-regional schemes in the Asia-Pacific region. Recent contributions to this line of thought include an appraisal of APEC, the trans-pacific mechanism focussing on economic cooperation, and a comparison of the East Asian and the European process of economic integration.

Karen Shire with GLOW Network

Globalization, Gender and Work Transformation -- GLOW (funded in the reporting period by the Institute of Social Sciences, University of Tokyo, University of Bremen, the Hanse Wissenschaftskolleg, Japanese Society for the Promotion of Science, British Social Research Council)

In the sixth year of its existence, the GLOW network is comprised of social scientists from Germany, Japan, the U.S. and U.K.

In 2004 this international network received a large grant from the Japanese Society for the Promotion of Science, under the leadership of Professor Mari Osawa, Institute of Social Science, University of Tokyo. Two workshops were carried out, the first in Tokyo and Yugawara, the second in the Lake District, UK. Network members also held two public seminars: the first at the Institute of Social Sciences at Tokyo University on Women and the New Economy and a second on Gender Mainstreaming in Comparison at Leeds University, UK. The network completed a book manuscript on Gender and the New Economy, which has received a positive peer review and contract from Palgrave Press. With the completion of this book project, the international network has turned to three further areas of research cooperation: an international comparative survey on female knowledge workers, an extended analysis of gender and the new economy utilizing census and micro-census data and a third project aimed at advancing theories of gender-based inequalities in international comparison. The data analysis on women in the new economy using census data will be co-ordinated out of the Institute of East Asian Studies in Duisburg. Karen Shire has also submitted a grant proposal with Karin Gottschall, University of Bremen, for an intensive working residency at the Hanse Institute of Advanced Studies, together with Mari Osawa (University of Tokyo) and Margarita Estevez-Abe (Harvard University).

Karen Shire (with Prof. Dr. Margret Borchert and Prof. Dr. Heinz-Ulrich Hoppe)

VIP-NET Virtual Working and Learning in Project-Based Networks (funded by the German Federal Ministry of Education and Research – BMBF 2003 - 2007)

This project, which commenced in August 2003, is focussed on understanding the role of project-based work in the production and sustaining of organisational networks. The project involves an interdisciplinary collaboration with scholars in the fields of Information Sciences and Personnel Management. The Sociological part of the project is focussed on the dual-formation and generation of project organisations and network organisations. Further details will become available at the following website: <http://soziologie.uni-duisburg.de/forschung.html>. In 2004 the project completed a first workshop, presenting the research design to representatives of the Ministry research administration partner, external experts and with the participation of other projects in the BMBF research program on virtual organisations from the University of Dortmund and the Fraunhofer ISY in Karlsruhe. Field research on virtual organisations was commenced in the summer of 2004.

4.3. Newly acquired Research Projects / Neu eingeworbene Projekte

Florian Coulmas, Patrick Heinrich

Intensive Course on Language and Economy and Publication of a Textbook on Language and Economy (funded by The Japan Foundation)

The economy of language is a new perspective in linguistics which has been advanced in Germany and Japan by Inoue Fumio and Florian Coulmas respectively. Inoue presented and discussed issues concerning the correlation of economics and language in Japan. In more concrete terms, he dealt with questions such as how the value of the Japanese language can be calculated and how the further demand of Japanese as a foreign language can be estimated. An even stronger orientation towards applied linguistics was the topic of how the teaching methods of Japanese as foreign language could pay due attention to the growing diversity among language learners of Japanese. A publication of Inoue's lecture is in preparation.

International Conference on Changing Language Regimes in Globalizing Environments, Europe and Japan (funded by VolkswagenStiftung)

Thomas Heberer

Theory and Application of the Concept of “Strategic Groups” – Scope and Limitations of a Social Science Paradigm between Structure and Action (funded by Kulturwissenschaftliches Institut Essen (Institute of Cultural Science), 2004-2006)

The concept of “Strategic Groups” developed in the 1980s by sociologists of development studies at Bielefeld University addresses the issue of how to define new social actors in developing societies, particularly in East and Southeast Asia. This concept proves to be a useful instrument in order to analyze social change and the emerging of new social players in developing societies. Three issues are central for further research:

- The role of strategic groups in processes of social transformation
- Strategic groups and counter-strategic groups
- Strategic acting as concrete and “directed” acting

The academic core group intends to explore the role of strategic groups in developing countries by means of case studies and to trace out in which manner the concept of strategic groups may contribute to a better understanding of social interaction and social and political change in the countries concerned.

Patrick Heinrich

Underlying Language Ideology of the Research Commission on the National Language (Kokugo chōsa i'inkai) (funded by DFG, travel grant)

What role did Modern Japanese play during the Japanese nation building process is the key issue in this research project. Being the first non-Western country to join the modern world Japan faced the difficult task of combining an indigenous tradition with Western progress. This led to new ideological assessments of many things Japanese, language being one of them. Language ideology is conceived here as an in-

vestigation into origin and effect of beliefs about language structure and use as well as the way in which these beliefs are promoted and spread beyond those social groups whose interest they serve. With regard to the role the National Language Research Council (Kokugo chōsa i'inkai) played in the formation of modern language ideologies the following two issues are studied:

1. What influences did language ideology take on the assessment, structure and use of Modern Japanese?
2. How did the specific ideological beliefs come about and what interests did they serve?

The research project is interdisciplinary touching upon the fields of language, culture and history.

Werner Pascha (Project Supervisor)

KOPRA - Coordination Platform for Internships (www.kopra.org) (funded by Stiftung Mercator GmbH)

For about ten years, *KOPRA - Coordination Platform for Internships* has been supporting companies in Japan in their search for qualified interns from Germany. KOPRA offers companies a free service to directly address their target group by placing a precise offer on the KOPRA-website www.kopra.org. Furthermore, KOPRA relieves the companies from the load of administration of internships by providing free information about visa, housing, living costs etc. on its website. The increasing number of companies which participate in KOPRA's service and the *several hundred* interns who find an internship through KOPRA every year attest the success of the KOPRA concept.

Recently, KOPRA has been granted financial funds by the *Stiftung Mercator GmbH*, a German foundation located in Mülheim. Thanks to the generous support, KOPRA will be able to extend its services from *Japan* to Germany, as well as from Germany to *South Korea, PR China and the Republic of China (Taiwan)* within the next five years. As a final result, the internet platform shall be consolidated and a plurilateral network will be established. The project will also look into the possibilities of non-governmental organisations in international relations, given an international framework with lower transaction costs through the internet.

As from 2004, KOPRA is running a Head Office in Duisburg, which is based at the the Chair for East Asian Economics and Economic Policy (Prof. Pascha). Ms. *Julia Hollmann*, who completed her master course in Japanese Studies at Bonn University, has been coordinating the project since the beginning of this year. German and East Asian interns have already been sent to Tokyo, Shanghai, Taipei and Seoul to promote the KOPRA idea. The KOPRA project is also supported and accompanied by KOPRA e. V., a non-profit organisation chaired by Ingo Meierhans.

Case Studies on Disinvestment from the Japanese Market (financed by JETRO, Japan External Trade Organisation, 2004-2005)

In recent years, about one hundred instances of corporate disinvestment from Japan are recorded per year. There can be different motives behind such moves. Selling a Japanese subsidiary can, for instance, be the desired exit channel for an investor who has successfully restructured a failing Japanese company, or it can be due to the failure of the foreign investor to run his Japanese unit. The contributors will prepare several case studies on German companies that have withdrawn their investment from the Japanese market in recent years. The case studies will cover basic information about the business operations, as well as reasons for investment and disinvestment. It is hoped that some of the conclusions can help JETRO to refocus its wide spectrum of support measures. Independently from the case study project undertaken on behalf of JETRO, a doctoral project (Steffen David) currently analyses disinvestment from Japan more systematically.

Karen Shire (with PD Dr. Ursula Holtgrewe)

Global Call Center Project (funded by Hans-Böckler Stiftung)

This project involves an international team of social scientists engaged in the administering of a unitary survey and the conducting of qualitative research for the purpose of comparing the evolution of new models of industrial and labor relations in the service sector, using the example of call center work. The international coordinators are Rose Batt, Cornell University and Stephen Wood, University of Sheffield. The German project began in May 2004 and covers the survey and other research in Germany and Poland, allowing for a first look at the role of EU-extension on labor relations practices in the borderland between Germany and her eastern European neighbors. The project is overseen by a Council of experts coordinated by the Hans-Boeckler Foundation. At the first meeting of the Beirat in June, the survey instrument was refined and plans were made for a first workshop reporting results in June 2005. In September 2004 the telephone survey of call center managers was fielded. Asian participants in the international project include South Korea, Japan, the Phillipines and India.

Markus Taube

The Challenge to the EU by a Rising Chinese Economy (funded by European Commission, DG Enterprise)

In the course of the last quarter century China has become a major player in the global economy and today seems to be on a trajectory towards even greater prominence. This study deals with the question of identifying what challenges a rising Chinese economy might pose to the EU and particularly its new member countries, as well as the implications arising for the candidate countries. The specific economic structures and factor endowments of the ten new member countries Cyprus, Czech Republic, Estonia, Hungary, Malta, Latvia, Lithuania, Poland, Slovak Republic, and Slovenia and even more so the three candidate countries Bulgaria, Romania and Turkey seem to make them more susceptible to competitive pressure arising from a Chinese economy, that is increasingly integrating in the global economy, than the EU-15 economies which are featuring a significantly higher state of industrialization. The study highlights the economic interfaces between Europe and China and evaluates the competitiveness of various industries in Europe and China today as well as their development perspectives in the near future. The study is designed as a background report to the Competitiveness Report 2004 by DG Enterprise, European Commission.

Markus Taube

The Chinese Iron & Steel Industry (funded by the International Iron & Steel Institute, Brussels)

The steel industry is one of the industries facing the greatest exposure to the 'China factor'. China is presently producing about one fifth of global crude steel and consuming about one quarter. These shares have not been static, but are the result of a very dynamic process in recent years – a process which obviously has not come to an end yet. In recent years China has been responsible for about 90% of the growth of the global steel industry and China is posed to remain a major shaping factor in the years to come.

Given this situation, the developments in China must be of great concern to the global steel industry. Any developments directly or indirectly determining the speed and prospects of China's economic growth process do have an explicit impact on the prices, capacity utilization as well as overall development of the steel industry in China and in the global markets.

But within China, having (in the minds of political decision makers) lost its strategic importance as the driving force of economic development, the iron and steel industry is no longer at the centre of economic policy making. Today it has lost its priority status and faces tough competition for scarce (financial) resources. At the same time the micro-economic organisation and management of the iron and steel industry and its enterprises has been revolutionised. Hierarchical interaction has to a considerable extent been substituted by marked based, horizontal patterns of cooperation and competition. But this micro-economic reorganisation of the Chinese iron and steel industry, the redistribution of property rights and decision making power has not yet been finalized. The result is a highly opaque situation, characterized by ambiguous ownership structures, decision making power being invested with people outside the regular organisational structure and a highly complex system of interdependencies and third party influences.

Research Module 1: Analysis of the operating framework for the Iron & Steel Industry in China

The objective of this module is to provide a reliable analysis of the factors determining the development of the Chinese economy in general and the steel industry in particular up to the year 2010 and which are not in the direct influence of the steel industry. The module will provide insights in the structure and mechanisms of economic policy making in China, especially emphasizing the interplay between central and local actors. Major questions to be answered are:

- Can China uphold political and social stability ?
- How sustainable is the Chinese economic development process (overall fit of institutional and social development, environmental degradation) ?
- How efficient is China's economic policy (center-local conflict, opaque delineation of competencies and responsibilities, state capitalism)?

Research Module 2: Micro-analysis of the Chinese Iron & Steel Industry

The objective of this module is to provide background information on the internal organizational structure and business situation of China's iron and steel industry. It shall provide information on the following topics in large, medium and small enterprises:

- Industry structure and corporate governance
- Financial performance
- Investment position
- Human resource endowment

Intensive Course on Language and Economy

Lun Du held a seminar “Geschichte der minben-Idee” at Ruhr-University Bochum (with Prof. Roetz)

In his lectures Prof. Dr. **Fumio Inoue** (Tokyo University of Foreign Studies) presented and discussed issues concerning the correlation of economics and language in Japan. (June 2004)

Research Seminar on Popular Culture and its Impact on National Stereotyping

A research seminar on popular culture and its impact on national stereotyping was organized by **Wolfram Manzenreiter** during the summer term 2004. Students of East Asian studies or sociology designed a study for assessing the relationship between the consumption of popular culture and attitudes toward Japan. Three subdivisions were built in order to elaborate on theoretical basics, logistics (= the produc-

tion and distribution of Japanese popular culture in Germany) and consumption. The study report is expected to be published in the Institute's own working paper series.

German-Japanese Workshop „Simulating business negotiations“

On December 6th 2003, for the fourth time a workshop on business negotiations “Joint Ventures with Japanese Enterprises” was organised by **Manja Jonas, Roman Bartnik** and **Ingo Meierhans** from the East Asian Economic Studies Chair (Professor Pascha). The participants, Japanese visiting students as well as students from East Asian Studies and Business Studies, had to act as board members of Japanese and German companies. They were asked to negotiate a Joint Venture with a company from the other country. As “coaches”, Dr. Hans-Christoph Pohl (formally of ABB Japan and Mr. Atsushi Kataoka (NEC Germany)) kindly offered their expertise. For preparation the participants received information about leadership and decision making structures in Japanese enterprises. Moreover, they were offered a lecture on how to prepare and execute negotiations in Japan. With the support of AlFreDO e.V., Ms. Iris Kuhnert, Manager of ICM Consulting Leverkusen, took over this task.

Video-Conference on Japanese Management

In summer term 2004, a lecture on Japanese Management was offered by means of a video-conference. **Dr. Jörg Raupach**, honorary lecturer of the department of business studies and president of NEC Schott in Japan, lectured and discussed four hours each with the participating students. Topics included basics of Japanese management, corporate governance, organisational structure, marketing and human resource management. This theoretical knowledge was applied to a case study of the Japanese semi-conductor industry. The video-conference was accompanied by two tutorials, led by **Peter Klöpping** and **Roman Bartnik** of the chair for East Asian Economic Studies (Professor Pascha). The whole project was supported by the media-center (Audiovisuelles Medienzentrum AVMZ) of the University.

The aim of the conference was to further our understanding of the forces currently at work in changing the linguistic landscape of the world. 7. Duisburg East Asia Day / Duisburger Ostasientag

„Technology, Culture and Development“

Since the industrial revolution spread from Europe, technology has been considered the most important instrument for solving most problems of humankind. Not only the exploitation of natural resources but life and death, laughter and pain, health and education have become technical/technological problems. This attitude has asserted itself in many parts of the world. Some of the most important inputs for development driven by technological progress originate in East Asia.

This raises the question of how technology and culture are related. Has culture become a decoration in the „technology age“ or does it remain an autonomous force? Is the treatment of technology – its development, its application, its social acceptance – different in East Asia from than in Europe and North America? Or does the power of technology as a component of globalisation level the playing field on an international scale? Do different cultures make use of technology or are they a servant to its logic? Does technological progress follow the needs of people or is it determined by the demand of markets? How does technology influence the East Asian cultures, and how do these cultures shape technology? These and related questions were discussed in the course of a stimulating panel discussion during the 7th East Asia Day organised by the Institute of East Asian Studies on the November 14, 2003.

The Rector of the University of Duisburg-Essen, Professor Dr. Lothar Zechlin, opened the event with a welcoming address towards the audience stressing the importance of the Institute of East Asian Studies in Duisburg. He described the Institute as a vivid sign of demand from students and the public on the one hand and pointed to the supply of interdisciplinary research on this important global region on the other.

Professor Dr. Florian Coulmas, Director of the Institute, continued by introducing this year's topic „Technology, Culture and Development“. In his speech Professor Coulmas focused on the perception of technology by societies. Different schools in science perceive technology in different ways. While engineering scientists have a deterministic understanding of technology, economists reduce technology to its consequences for growth. The spill over effects between mankind and technology however are discussed by social and cultural sciences.

Coulmas' speech was followed by a very interesting panel discussion. The moderator of the panel, former Rector Prof. Dr.-Ing. Ingo Wolff, introduced the panel members. Wolff asked the panelists how „western“ technology is present in East Asia nowadays and how to assess the influence of East Asian technology on western culture. These questions led to an very controversial debate. Focusing on China, Professor Dr. Michael Lackner, Sinologist at the Friedrich-Alexander-University in Erlangen-Nürnberg, stated that the first seven decades of the 20th century did not bring about much “technology” in the western sense due to the resistance of Chinese elites. Professor Dr. Hans van Ess (Ludwig-Maximilians-University Munich, East Asia Institute) raised the point that the “other” Chinas such as Hong Kong and Taiwan have had very different developments. Whereas the Cultural Revolution in the PR China had cut many traditions, a “re-invention” of traditional values can be observed nowadays. Coulmas and Prof. Dr. Horres (Tübingen University) pointed towards the technological innova-

tions in Japan such as the improvement of mechanic watches and as a recent example “fuzzy technology”.

Introducing a new point, Wolff asked the panel which role “cultures” such as families, hierarchies, etc. played for the invention of technology. Dr.-Ing. Joachim Lorenz, formerly executive manager at ThyssenKrupp AG, argued that hierarchies had played a strong role. However, this has changed recently as the seniority principle is losing importance and western companies have become an “engine” in technological growth. Dr. Thomas Mühlenbernd, Department Head at BASF, mentioned as a general impression that basic inventions are made in the West, but the realisation and application is done in Japan and Asia.

In the final round the panelists discussed the influence of culture on technological progress. The statement of the “leading west” was questioned by the speakers. Coulmas remarked that more important than “leading” is the development into the “same” direction. Horres countered that the “leading West” is an old stereotype as the Japanese companies complain about “merry” students. Lackner added that Germans are perceived as “lazy” not disciplined in modern China.

Many questions were addressed from the audience touching on topics such as globalisation and bio-ethics until Wolff asked the panelists to close with a final comment on the cultural support for development of technology within East Asia.

The 7th East Asia Day closed with the award of the Alumni-Prize 2003 for the best Diploma Thesis in East Asian Studies in Duisburg..

13 LIBRARIAN'S REPORT BIBLIOTHEKSBERICHT

The East Asian Studies collection comprises about 23.000 monographs and more than 200 periodicals as of Sept. 2004.

All of these titles can be searched electronically in the OPAC of the University Library Duisburg-Essen (<http://aleph02.ub.uni-duisburg.de>) and also in the OPAC of the Union Catalogue of the University Library Network in Northrhine-Westfalia (<http://193.30.112.134/F/>).

Although library funds were restricted during the reporting period, approximately 300 new monographs have been added to the collection. In this regard we are thankful to the Japan Foundation for its generous donation of some precious collected works.

Once again it was necessary to cancel several journal subscriptions, due to funding restrictions imposed on the collection this year.

At the national level, the East Asian Studies library continues working in association with CJK (Chinese, Japanese and Korean) libraries and an association of Japanese libraries.

In the end of the year 2002, a journal article service on demand was established, covering subscriptions to six libraries. This arrangement was extended this year as the participation of libraries in the service has grown. A similar service by the Chinese libraries would be appreciated.

At an international level, a cooperation with the National Institute for Informatics (NII) has continued. Since March 2003, the NII has allowed the institute to use their 36 databases and 80 electronic journals free of charge. This arrangement, which was originally limited through the end of March 2004 has been renewed for another year.

The parallel cataloguing of Japanese monographs has continued, using the original characters in NACSIS-CAT (Japanese Union Catalogue) hosted by NII. Approx. 2500 of our titles can be searched for with the Chinese and Japanese characters in <<Webcat>> (<http://webcat.nii.ac.jp>).

Nationenbildung in Malaysia als strategisches Staatshandeln. Bemühungen um die Schaffung nationaler Identität

Nationenbildung als strategisches Staatshandeln hat als Instrument der Konfliktprävention, politischer Stabilitätsfaktor sowie Abwehrinstrument des Staates gegen innere und äußere destruktive Kräfte Bedeutung erlangt. Malaysia stellt dabei ein Erfolgsbeispiel dar. Als postkolonialer Staat mit künstlich gezogenen territorialen Grenzen, einer heiklen ethnischen Konstellation und einer relativ jungen nationalen Geschichte arbeitet das Land seit 1957 an der „malaysischen Nation“. In den Jahrzehnten nach der Unabhängigkeit vollzog sich seine beachtenswerte wirtschaftliche und soziale Entwicklung zu einem „Schwellenland“. Für zahlreiche andere islamische Staaten der so genannten Dritten Welt stellt der Weg Malaysias ein Vorbild dar. Im Land selbst wird dieser Erfolg indes mit großer Skepsis betrachtet. Diese Arbeit analysiert die Strategien, die die Regierung Malaysias angewandt hat, um nationale Einheit und Identität herzustellen. Damit wird erstmals eine systematische Untersuchung vorgelegt, die Prozesse der Nationenbildung trotz aller Individualität der Einzelfälle einem Vergleich zugänglich macht.

**Why Ideas Matter:
Ideen und Diskurse in der Politik Chinas, Japans und Malaysias**

Es war nicht zuletzt die „Asienkrise“ von 1997/98, die eine Neubesinnung auf „demokratische“ Werte und Institutionen in Ost- und Südostasien mit auslöste und die Notwendigkeit politischer Veränderung offenbarte. Davon ausgehend haben sich die Autoren in einem Forschungsprojekt mit der Bedeutung von Diskursen für den erhofften politischen Wandel befasst. Im Mittelpunkt dieser Studie steht die Frage nach der Rolle von Ideen in politischen Gestaltungs- und Entscheidungsprozessen: Ideen generieren die Inhalte politischer Diskurse, fließen in den Austausch über Reform- und Demokratisierungskonzepte ein. Doch wie gelangen Ideen von ihrer Produktionsebene bis zur politischen Entscheidung? Diese in der Politikwissenschaft bislang kaum behandelte Frage wird für drei Länder aus der Region Ost- und Südostasien behandelt. Die VR China stellt ein Beispiel für einen autoritären Staat dar, Malaysia gilt als multiethnischer, formal demokratischer Staat mit starken autoritären Zügen, und Japan zählt zu den fortgeschrittenen Demokratien, weist aber auch signifikante parochiale Strukturen und Verhaltensmuster auf. Die Studie identifiziert übergreifende Parameter, anhand derer die Diffusion von Ideen in die Politik vergleichend untersucht werden kann, etwa das Timing von Diskursinhalten, intellektuelle Ressourcen, soziales Kapital oder Netzwerkbildung. Die Ergebnisse basieren auf Tiefeninterviews mit politischen Thinktanks, Intellektuellen, Politikern und Mitgliedern von Nichtregierungsorganisationen der genannten Länder.

Advertising and Marketing in the People's Republic of China

Over the past two decades China has become one of the most attractive locations for foreign direct investments. Apart from looking for cheap labour, foreign investors are attracted by the supposed large Chinese market for their products. One result of this investment drive has been fierce competition within the Chinese market between foreign investors, indigenous enterprises and joint ventures. In this situation of fierce competition successful advertising strategies are important to secure market share. Research on the advertising business in China, on the reception of advertising by Chinese consumers, changing consumer behaviour etc. has nonetheless been scarce. This in-depth study of advertising in China thus aimed at closing this gap. The study starts with an overview over the general economic situation as far as it is relevant for understanding the development of the advertising business. The second part of the study deals with the legal, cultural and socio-economic environment (consumer behaviour, advertising beliefs etc.) of advertising in China. The third and the fourth part analyse the development of the advertising industry and the media. The last part of the study presents results of a survey among advertising enterprises concerning their experience within the Chinese market. One important result of the study is, that the advertising business is experiencing fast changes in many aspects, be it the legal environment, consumer behaviour and tastes or media organization. The biggest challenges for advertising agencies as well as enterprises planning an advertising strategy lies in keeping track of these changes. This is especially true as the advertising market is far from being transparent. The study thus hopes to add to transparency.

Systemic Change in the Japanese and German Economies. Convergence and differentiation as a dual challenge

Should Japan and Germany strive to restructure their institutional fabric and arrangement to make them more similar to Anglo-American standards? Where will systemic change lead? This book offers fresh insights by collecting Japanese and German contributions to this scholarly discussion both from theoretical and empirical viewpoints. A major conclusion of several papers is that the forces of differentiation are frequently underestimated. Important thematic issues include: contingency, path dependence and complementarity. Examinations of economic globalisation and rapidity of technological change pose questions about the nature of socio-economic system analyses in the future.

Korruption in Hongkong. Eine Analyse zum Zusammenhang von Souveränitätswechsel und Korruptionsentwicklung [Corruption in Hong Kong. An Analysis of the Relation between the Transfer of Sovereignty and the Development of Corruption]

The hand-over of the British colony Hong Kong to the P.R. China in 1997 has been widely observed and commented internationally. In this context fears were expressed that corruption in Hong Kong, which in contrast to China has been acknowledged to be successfully controlled, will rise notably. This survey examines how far the change of sovereignty has led to an increase in corruption in Hong Kong. The analysis however, does not merely focus on the formal date of the hand-over but considers, too, the period of its preparation especially since the beginning of the 1990s. This approach was chosen in order to show how the changes in the political-administrative, economical and socio-cultural field have in the long-term developed new occasions and incentives for corruption. On selected cases the survey points out where fields with a high potential for corruption have arisen. Parallel, the survey also analyses existing control mechanisms which have so far counteracted an extreme increase in corruption in Hong Kong. On the gained perceptions the survey finally

comes to an estimation of the present degree of corruption in the Special Administrative Region of Hong Kong.

Gesprächserwartungen. Eine kontrastive Studie über die Gesprächsführung in deutschen und japanischen Telefonaten (Reihe Duisburger Arbeiten zur Sprache- und Kulturwissenschaft, herausgegeben von Ulrich Ammon et al., Bd. 54. Frankfurt am Main: Peter Lang, 2004).

Telefonieren ist eine alltägliche Beschäftigung. Inzwischen haben sich selbstverständliche Verhaltensweisen beim Telefonieren fest in unserem Alltag etabliert. Je doch bleiben sie in vielen Fällen latent. Welches Verhalten erwarten wir in einer bestimmten Situation als selbstverständlich vom Gesprächspartner? Was passiert im Enttäuschungsfall? Auf der Grundlage der ethnomethodologischen Konversationsanalyse und der deutschen Gesprächsforschung wird die verbale Interaktion im Alltag analysiert. Die Daten sind Tonbandaufnahmen natürlicher Telefongespräche jeweils unter Deutschen und Japanern in ihrer Muttersprache. Die Arbeit macht konkrete Erwartungen in unserem Alltag sichtbar und fordert ihre Bewusstmachung vor allem bei der Kommunikation zwischen Mitgliedern verschiedener Sprachgemeinschaften.
