SPOTLIGHT IM BLICKPUNKT

Risk and East Asia: An Anglo-German Research Training Program in Discipline-based East Asian Area Studies



In May 2009, following an on-side peer review in February, IN-EAST was awarded funding by the DFG to set up the Research Training Group, officially commencing in October 2009. The research intentions of the program are three-fold:

- (1) to contribute to social scientific and comparative theories of institutional change by studying how the responsibilities for governing and protecting against social, political and economic risks are shifting from states to markets, public to private bodies and from collectivities to individuals,
- (2) to study institutional change in a region of the world – East Asia – where institutional logics have played out historically in different ways, and
- (3) to integrate strong research methodological training with research and language competencies in East Asian research contexts.

The innovation of the research program lies in taking a risk perspective on institutional change, tying together specific disciplinary perspective with that of regional studies, in an intra- and inter-regional research design. The sub-themes of the research program examine the impact of four “large processes” of contemporary transformations on shifting risks in specific cases of institutional dynamics: marketisation, individualisation, decentralisation, and transnationalisation. The research training program is an explicitly international collaboration with the UK center of excellence – the White Rose East Asian Centre – in cooperation with major centers of social scientific research in East Asia, the Faculty of Sociology and Population Studies at the Renmin University in Beijing and the Institute of Social Sciences at the University of Tokyo in Japan. The disciplinary and methodological expertise of the German participants is complemented by the regional expertise of the British researchers with the aim of achieving excellence in combining methodological and language training in social scientific regional studies. The collaboration involves jointly developed training measures, planned at key milestones in the development and execution of doctoral research projects within a structured three-year doctoral curriculum. A key innovation of the training program is “mobility together” to East Asia, for an intensive seminar about research methods and implementation with scholars in East Asia, hosted by Renmin University and the University of Tokyo, and scheduled prior to doctoral candidates’ independent field work. This key innovation is aimed at improving research training for methodologically sound research in discipline-based East Asian regional studies, and the integration of doctoral fellows early-on into scientific research communities in East Asia. The final year of the program includes measures aimed at preparing doctoral fellows for productive research careers with an orientation toward English language and peer review publication of research results.

Participating social scientists from IN-EAST include **Prof. Dr. Werner Pascha**, **Prof. Dr. Thomas Heberer**, **Prof. Dr. Markus Taube**, **Prof. em. Dr. Winfried Flüchter**, **Dr. Kerstin Lukner**, and **Prof. Dr. Karen Shire** as speaker.

Between June and September 2009 a number of appointments were made to the research staff of the training group. Alongside a new coordinator for the program, Ms. **Uta Golze** (Münster and Berlin), two new post-doctoral scholars were selected: **Dr. des. Norifumi Kawai** (Duisburg), and **Dr. Akihiro Ogawa** (Stockholm). The post-doctoral scholars develop research projects within the group and participate in the qualification program for doctoral fellows.

Stipends were awarded to five young scholars, four of whom joined the group in October 2009: **Chih-Chieh Wang** (Taiwan National University), **Melanie Wacker** (Leiden University), **Armin Müller** (Tübingen University), and **Jan Fischer** (University of Duisburg-Essen). Two further IN-EAST doctoral candidates have been coopted into the research training group: **René Trappel**, researcher in the DFG funded project “Politics and Autonomy in the Local State in China”, and **Sunkung Choi**, DAAD fellow. IN-EAST MA student **Iva Ognanovic** was awarded a stipend as a pre-doctoral research fellow in the group.

Southeast Asia Field Trip February 22–March 9, 2009

Students of our Diploma Program East Asian Studies went on a field trip to Cambodia and Vietnam to study urbanization processes and city planning. The field trip was organized by PD Dr. Thomas Feldhoff and Dr. Helmut Schneider of the department of Human Geography – East Asia. Here is a short report in German:

Vom 22.2. bis 9.3.2009 haben zwölf Studierende der Ostasienwissenschaften (Hauptfach Geographie) und neun Lehramtsstudierende mit dem Fach Geographie unter Leitung von PD Dr. Thomas Feldhoff und Dr. Helmut Schneider eine Exkursion in die südostasiatischen Länder Kambodscha und Vietnam durchgeführt. Inhaltlich lag der Schwerpunkt der Exkursion auf dem Studium von Prozessen der Urbanisierung, Stadtentwicklung und Stadtplanung, wie sie sich unter verschiedenen historischen, kulturellen, ökonomischen und politischen Bedingungen entfaltet haben. Vietnam zählt nach den Doi-Moi-Reformen heute in Südostasien – auch nach dem Einbruch der jüngsten Finanz- und Wirtschaftskrise – zu den schnell wachsenden Boomstaaten, während Kambodscha trotz erster Entwicklungserfolge (v.a. im Textilsektor) noch zu den ärmsten Staaten der Region gehört. Hier wirken die Zeit der Khmer-Rouge-Herrschaft (1975–1979) und der bis in die neunziger Jahre anhaltende Bürgerkrieg noch nach.

Die Exkursion führte zunächst nach Kambodscha, erste Station war die im Nordwesten gelegene Stadt **Siem Reap** mit dem unmittelbar benachbarten weiträumigen archäologischen Komplex der Tempelruinen von **Angkor**, einem der größten Siedlungskomplexe der vorindustriellen Welt auf der Grundlage einer „hydraulischen Gesellschaft“. Die Stadt Siem Reap ist durch den noch weiter wachsenden, auf Angkor gerichteten Strom des Massentourismus, inzwischen überwiegend aus Ostasien, zu einem boomenden Regionalzentrum und zur zweitgrößten Stadt des Landes geworden.

Per Boot führte die Exkursion weiter über den großen, ökologisch einzigartigen Binnensee Ton le Sap nach **Phnom Penh**. Die Stadtentwicklung Phnom Penhs wurde und wird durch die hydrologische Situation bestimmt (Eindeichungen, Wasserregulierung, Freipumpen tiefliegender Flächen). Stadtbildprägend ist bis heute die Mischung aus (theravada)buddhistischen Elementen (Königspalast, Tempel), kolonialer Stadtplanung und Architektur, ergänzt um Elemente der kurzen kambodschanischen Moderne in den sechziger Jahren. Erst in jüngster Zeit hat eine moderne Citybildung eingesetzt. Phnom Penh wird in Kürze nicht mehr zu den wenigen Zentren Südostasiens zählen, die bisher noch nicht über eine Hochhaus-Skyline verfügten.

Per Bus ging die Reise weiter über Land nach Vietnam. Ziel war **Ho Chi Minh City** (HCMC), das frühere Saigon, heute die unbestrittene Wirtschaftsmetropole Vietnams. In HCMC hatte die Exkursionsgruppe Gelegenheit, sich an der „University of Architecture“ und von Vertretern des UN-geförderten „Urban Environmental Planning Programme in Vietnam“ über neuere Prozesse der Stadtentwicklung informieren zu lassen, die an ausgewählten Beispielen (u. a. Umsiedlungsprogramme für Squatter, neue urban developments am Südrand der Stadt für die wachsende Mittelschicht) auch vor Ort in Augenschein genommen werden konnten. Abgerundet wurde die Visite in HCMC mit einer kombinierten Bus- und Bootstour in das **Mekong-Delta**, das durch große Infrastrukturprojekte immer enger an HCMC angebunden

wird. Der landwirtschaftliche Gunstraum ist allerdings ökologisch sehr fragil und insbesondere durch den Klimawandel großen Risiken ausgesetzt.

Nächste Station war die alte Kaiserstadt **Hue**, nördlich der Metropole Da Nang im Zentrum Vietnams gelegen. Die Stadt wird bisher erst randlich vom Wirtschaftsboom erfasst, zeigt aber mit dem stadtbildprägenden Kaiserpalast und der Zitadelle, auf welche Weise hier chinesische Kultureinflüsse auf die Stadtentwicklung eingewirkt haben. Abgeschlossen wurde die Exkursion schließlich in **Hanoi**. Das politische Zentrum des Landes nimmt ökonomisch nach HCMC im Süden klar den zweiten Platz ein. In Hanoi überlagern sich in der Stadtentwicklung vorkoloniale Elemente, koloniale Stadtplanung und „realsozialistische“ Herrschaftsarchitektur. Moderne urbane Formen beginnen sich erst in größerem Stil auszubilden. Besonderes Interesse fand das dichtbebaute vorkoloniale 36-Gassen-Viertel mit seiner beeindruckenden Funktionspersistenz von Handwerk und Handel.

IN-EAST Summer School “Zukunft Asien” August 2–6, 2009



For the first time the IN-EAST carried out a summer school in the beginning of August. 40 pupils from senior high school participated and enjoyed lectures and language training to gain a first hand insight into the study programs offered by the IN-EAST. The institute hopes to attract excellent pupils for its programs by this offer.

In the program scientists of the IN-EAST introduced important developments in East Asia, lecturing on topics such as China’s Role in the Global Economy,

Regional Integration in East Asia or the Aging Japanese Society. The participants also attended very intensive introductory classes into the Chinese or Japanese language to test the challenge of learning an East Asian language. Working groups, meetings with alumni, an excursion to Düsseldorf and some cultural events such as the joint visit to the open air cinema in an old steel mill at the Landschaftspark Nord were included in these very intensive five days of last year’s summer school entitled “Future Asia”. The students highly appreciated the summer school and assessed it as good or even very good. In the following you will find some excerpts from statements of the participants about the summer school:

„Der Bereich, den ich ins Auge gefasst hatte – Studium der Ostasienwissenschaften – bietet vergleichsweise wenig Orientierungshilfen vor der Studienwahl. Ein absoluter Treffer ins Schwarze begegnete mir jedoch im Internet: Eine fünftägige Summer School der Universität Duisburg-Essen. Diese sollte Schülern und Schülerinnen der Oberstufe einen Überblick über die Chancen und Risiken in der Region Ost- und Südostasien und ihre Entwicklung verschaffen. Außerdem konnte man beim morgendlichen Intensiv-Sprachtraining feststellen, ob einem das Erlernen einer ostasiatischen Sprache liegt.“ (Sonja Merkl)

„Als ich von meinem ehemaligen Lateinlehrer den Flyer der IN-EAST Summer School der Universität Duisburg-Essen las, war das Erste, was ich dachte: ‚Wow, das ist es!‘ Denn für mich steht schon seit langer Zeit fest, dass ich Sprachen liebe und dass mein Herz für andere Länder und Kulturen schlägt. Ich war mir nur nicht sicher, welcher Weg mich dorthin führen würde, was meine Leidenschaft für Sprachen und Kulturen mit einem Beruf verbinden könnte. Mir war klar, dass ich mit der Summer School einen Weg betreten würde, ‚um der Zukunft einen kleinen Schritt näher zu kommen‘.“ (Pia Schüßler)

„Gemeinsame freudige Erwartungen erfüllten sich auch schon beim ersten Sprachtraining (man hatte am vorigen Abend Chinesisch oder Japanisch wählen können). Unsere Chinesischprofessoren Frau Yang und Herr Du trafen auf einen ausnahmslos eifrigeren, begeisterten und motivierten Kurs – ein seltes Bild für mich, eine Schülerin der 13. Stufe. Im Japanischkurs dürfte es wohl genauso gelaufen sein, den nachher fröhlich herumlaufenden und Japanisch sprechenden Jugendlichen nach zu urteilen. Tatsächlich – es waren auch Jungs dabei!“ (Sonja Merkl)

„Mein schönstes persönliches Erlebnis fand an dem Abend statt, an dem alle zusammen im chinesischen Restaurant zu Abend aßen und danach in der angrenzenden Lounge mit Bar einen Karaoke-Abend veranstalteten. Wie gesagt – eine lange Nacht. Das Highlight: Diplom-Studenten des Studiengangs kamen hinzu und fingen – zu unserem allseitigen Erstaunen und zu unserer Faszination – an, die chinesischen Karaokelieder mitzusingen, wofür sie die original chinesischen Zeichen (für die meisten von uns nur eine homogene Masse) ablesen mussten. Das war in den Augen der meisten eine außergewöhnliche Leistung.“ (Sonja Merkl)

„Ich bin sehr erfreut und zugleich überrascht über die Vielfalt der Vorträge und das Interesse aller Teilnehmer und Teilnehmerinnen. Denn ich konnte beobachten, dass alle den Vorträgen interessiert gefolgt sind, ganz gleich wie wenig geschlafen wurde oder wie anstrengend der Tag war. Zu dem kann man einen deutlichen Unterschied zwischen den Professoren und Lehrern an der Oberstufe erkennen. Mir ist klar, dass der Start des Studiums eine große Veränderung bringen wird, am meisten vermutlich im eigenen Lernverhalten. Es hat mir sehr gefallen, dass die Professoren bereit waren eine breite Themenwahl in einem Vortrag zu vermitteln. Denn Ziel war es, dass wir einen Einblick in den Studiengang Ostasienwissenschaften bekommen konnten.“ (Pia Schüßler)

„Uns wurde das Institut für Ostasienwissenschaften vorgestellt, wir erfuhren einiges über den Studienverlauf sowie über die Möglichkeiten, die das Studium von Ostasienwissenschaften mit sich brachte, und durften ehemaligen Absolventen des Studiengangs Fragen stellen. Diese Einführung halte ich im Nachhinein für besonders wertvoll, denn gerade zu Beginn der Summer School war es für alle Teilnehmer äußerst wichtig zu erfahren, welche Erfahrungen Studenten in den vergangenen Jahren bereits gemacht haben und was dieser Studiengang für den späteren Berufsweg an Möglichkeiten eröffnen kann.“ (Lisa-Marie Janßen)

„Auf die Referate folgte der wohl für alle eher negative Teil der Summer School, denn auf dem Plan stand die „Feststellung der Sprachfähigkeit und Abschlussprüfung“, worunter wir uns nichts konkret vorstellen konnten. Letztendlich waren die Befürchtungen aber unbegründet, da die „Feststellung der Sprachfähigkeit“ aus einem kleinen Test bestand, der aber natürlich nur das umfasste, was wir in den Sprachkursen erlernt hatten und somit für alle zu schaffen war. Die „Abschlussprüfung“ war ein Aufsatz, den wir schreiben sollten, zu der Aufgabe: „Nennen sie die drei für Sie wichtigsten Entwicklungstendenzen in Ostasien und erklären Sie diese kurz.“ In den Tagen zuvor hatten wir einiges darüber gehört und konnten nun alle einiges dazu schreiben. Für mich, und wohl auch viele andere, war die Zeit viel zu kurz, weil es schwer war sich so kurz auszudrücken. Wir hatten wohl einfach viel zu viel gelernt.“ (Pia Schüßler)

„Als meine Freundin und ich darüber nachdachten, mit wie wenig wir hier angereist waren (Block, Stift), fanden wir es beachtlich, wie viel man in ein paar Tagen lernen und erfahren kann. Ich persönlich bin mir jetzt der Anforderungen bewusst, die der Studiengang mit sich bringt – eine sehr gute Basis, auf der ich mich höchstwahrscheinlich für das Studium der Ostasienwissenschaften entscheiden werde.“ (Sonja Merkl)



Demographic segregation and retirement communities in Japan. A new objective for regional revitalization policies?

Funded by the Foundation of German Humanities Institutes Abroad (DGIA)

In looking at the fragmentation of urban social space, leading scholars of postmodern urbanism have drawn our attention to the spatiality of contemporary cities. By highlighting such spatial features as “gated communities” and other enclaves, these urban theorists have made us aware of the evolving patterns of spatial restructuring associated with a distinctive kind of polynucleated and fragmented city form. Edward Soja uses the term “fractal city” to identify some of the major social and geographic outcomes of urban restructuring.

The growing popularity of retirement communities is one facet of the growing fragmentation of urban space along age. There is a growing need to develop proper retirement options for an ageing resident population pursuing their self-interests, seeing themselves residing in some utopia untouched by social, economic or ethnical divisions. As a result of these “hyperrealities”, spatial isolation and the decline of community identification in urban life undermine traditional social institutions.

The research project addresses the dynamics of demographic change in Japan and the problems and chances associated with setting up retirement communities for urban and regional development. Endogenous growth theory argues that economic growth can be generated from within a system as a direct result of internal processes. The degree of social and political acceptance of such age-restricted communities may not only be determined by normative decision making, but also by their real outcomes in terms of regional revitalization success.

Land Expropriation in China as a Challenge for Urban Administration and Governance – against a Background of China’s Land Utilization Law (*Bodennutzungsrecht*) and Germany’s Hereditary Leasing Rights (*Erbbaurecht*)

(Concluded)

Theoretically, many expropriation procedures in China appear representative for what institutional economic analysis or the new political economy calls “rent-seeking” – what in reality could be better called “land-pressing”. The demolition of buildings, the resettlement of people and the appropriation of land often in favour of a few central local actors (‘winners’) at the expense of many affected dwellers (‘losers’) is closely connected with corruption whenever the compensation provided for the affected dwellers is much lower than the amount the local land market offers. We argue that land expropriation officially justified by emphasizing on the public good often serves as a **self-justification** for local patronage, collusion and corruption based on connection networks (*guanxi*).

Growth and Shrinkage in East and South East Asia. Challenges of Demographic Change against the Background of the ‘Flying Geese’ Model? Japan as a Trendsetter of New Urban Developments?

Current project

The ‘flying geese’ model of industrial development conceived by the Japanese economist Kaname Akamatsu in the 1930ies became a much discussed approach for the explanation of economic catching-up processes of the countries of East and Southeast Asia – in the context of a strong globalization of the Japanese economy since the late 1980s. The rapid demographic change in the states and territories of East and Southeast Asia, particularly population shrinking and ageing, is seen and evaluated against the background of this model. The concept of Japan as the ‘leading goose’ of an Asian-Pacific ‘flying geese formation’ is challenged not only with regard to economic but also to demographic and urban catching-up processes.

Public Housing and Urban Development in Singapore – Ethnic Groups between Residential Segregation and Residential Integration

Öffentlicher Wohnungsbau und Stadtentwicklung in Singapur: Ethnien zwischen residentieller Segregation und Integration

Funded by the German Research Association (DFG) 2001–2004, continued as PhD project

Public housing is regarded as one of the “pillars of the nation” when it comes to the integration of Singapore’s multi-ethnic population. By means of a well-contrived system for providing for their old age, almost 90 % of the inhabitants have become quasi-owners. The research project focuses at the micro-level on the degree of equilibrium and particularly the acceptance of the mixture of social and ethnic population that is consciously favoured by Singapore’s government. Of late it has been questioned, not only in Singapore, whether segregation would not be a (better?) alternative under certain conditions. With this question in mind we will evaluate Singapore’s strategy (“social and spatial engineering”). The discussion of the advantages and disadvantages of a balanced mixture and of segregation at the micro-level needs to be related to the macro-level. For the self-image of the “developmental state” of Singapore, public housing is of crucial importance as a sign of “nation-building”. The links between priorities at the macro-level and modes of behaviour at the micro-level will be analyzed. This project in the field of urban and political geography is based on a critical/hermeneutical concept of science and will apply approaches from decision and behavioral theory, with particular attention to the ethnic-cultural approach. Research fellow in the project is Will Hammelrath.

Die (In-)Stabilität autoritärer Regime (with Daniel Lambach)

Anschubfinanzierung durch den Profilschwerpunkt „Wandel von Gegenwartsgesellschaften“

In line with a growing body of literature that is concerned with the resilience of authoritarian regimes, we seek to understand why some authoritarian regimes are more likely to survive than others. However, we hold that it is important to not only look at the life-span of a regime, but also at its quality. For example, China and Myanmar are both long-standing authoritarian regimes, yet they are fundamentally different with regards to how their regimes function. While the ruling elites in China have taken great care to improve the institutional base that underpins their rule, such institutionalisation has been absent in Myanmar. For this reason, the capacity of the Chinese regime is far greater than that of Myanmar to flexibly react to social demands and thereby defuse (latent) conflicts. The Junta in Myanmar, on the other hand, chiefly relies on organized and, where possible, covert repression to uphold its rule. Yet different are regimes where repression is exercised overtly, like Liberia under Charles Taylor. Our aim is to identify the parameters of quality and responsiveness by means of a case study-based nested analysis. We first compare four long-standing authoritarian regimes from two continents that were all faced with major crises. China and Uganda have survived until this day, while Indonesia and Guinea collapsed in 1997 and 2008, respectively. In a second step, we test our model in a large-N analysis that utilises various indicators from existing indices.

Thomas Heberer (with Prof. Dr. Gunter Schubert, Tübingen University)**Politics and Autonomy in the Local State – County and Township Cadres as Strategic Actors in the Chinese Reform Process**

Funded by the German Research Association (DFG), 1/2008–12/2009

Any substantial assessment of China's state capacity cannot be undertaken without a careful analysis of the local state. County and township cadres are of utmost importance here – a fact which has rarely been researched so far. They have a high degree of autonomy vis-à-vis the central state und are the decisive actors concerning the implementation of China's agricultural policies and the government's efforts to reform the system of rural finance. It is the local cadres who decide about the central state's success to maintain social stability and regime loyalty among China's peasants. What kind of rationality do local cadres follow when they carry out central policies? To what extent do they develop a collective identity that makes them a self-conscious strategic group in China's political system, and how does this impact on state capacity and regime legitimacy? The project intends to find answers to this question by a systematic analysis of the implementation of the "Construction of a new countryside" comparing different counties and townships. By that, it makes an important contribution to the understanding of political development in contemporary China.

Thomas Heberer (with Prof. Dr. Dieter Grunow, Institute of Political Science)**Administrative Reform in Germany and China (2): Decentralized Policies in the Domain of Environmental Policies: Urban Areas**

Funded by the Haniel Foundation, 2006–2009

This follow-up project intends to scrutinize local administrative acting (or non-acting) in the domain of environmental issues. A comparison with German policies shall facilitate to learn from the experiences of an advanced country and its underlying concepts. Three case studies in Northeast, East and Western China had been conducted in September 2007. Four core issues of environmental policies will be examined:

- a) Environmental policies of various governmental echelons (local, province, centre) and their implementation.
- b) The role and acting of various players (various levels of government and party administration, enterprises, environment organizations (NGOs), the media, citizens, international leverage, etc.).
- c) Conflicts and conflict management.
- d) Elaboration of environment-oriented development strategies: The objective is to elaborate a policy paper and a proposal concerning the implementation and diffusion of an effective environmental policy in the sense of policy learning.

Thomas Heberer (with Prof. Dr. Dieter Grunow, Institute of Political Science)**Administrative Reform in Germany and China (3): Decentralized Policies in the Domain of Environmental Policies: Rural Areas**

Project of the Heinrich Böll Foundation in Cooperation with Communication Science at the University of Erfurt and the IN-EAST (Prof. Dr. Thomas Heberer)

This project examines and analyzes the contents and structures of the China coverage in German media in 2008. Intended is particularly the generation of reliable data for a discussion on China's image and presentation in Germany. The contents concerning China in major German media and the information flow via news agencies, correspondents in China and editorial offices and staff were scrutinized and analyzed in order to make the coverage of China more understandable.

The Governance of Pandemic Risks in East Asia

University of Duisburg-Essen start-up financing for the preparation of a research proposal to receive external funds

The research project undertakes a comparative study of pandemic risk governance in China and Japan. It focuses on the questions of how pandemic risks (avian influenza, swine flu) are perceived in China and Japan and how their governments have been reacting to this pandemic risk challenge.

Intraregional and Interregional Economic Relations in East Asia

Financed by the Korea Institute for International Economic Policy, the Academy of Korean Studies, etc., since 2000

Economic relations of Pacific Asia are studied from an institutional economic viewpoint. The rationality of various organizational mechanisms like APEC is analyzed within a politico-economic framework. Conventional economics often concludes that regional or even trans-regional mechanisms are saturated with potential organizational failure issues. For instance, they are very much detached, through various layers of legislature and executive, from the final principal, the individual voter. Moreover, such mechanisms often tend to avoid binding agreements and thus cannot effectively control for shirking or even defection. From a different perspective, though, scholars based in the international relations literature often see such organizations in a more positive light. They frequently stress that such regimes constitute a process in which trust and more reliable commitments can slowly evolve. The project tries to take these latter considerations seriously and to integrate such "evolutionary" issues into an analysis of the politico-economic mechanisms that define the intra- and interregional schemes in the Asia-Pacific region. Recent contributions to this line of thought include an appraisal of APEC, the trans-Pacific mechanism focusing on economic cooperation, and a comparison of the East Asian and the European process of economic integration.

KOPRA International Internship Platform

KOPRA has been growing since it came into existence about twelve years ago. Since 2004, KOPRA is affiliated to the Chair of East Asian Economic Studies / Japan and Korea as a third-party project founded by Mercator Foundation GmbH, Essen.

www.kopra.org now has an average of 400–500 different visitors per day. Over one million requests are made to our server within a month.

Although one-third of the open positions are offered in the field of Business and Economics, the numbers of internships in Engineering, IT, Architecture, Law, Language Studies and Design/Fashion also grew significantly. According to location, nearly 30 % of the internships are offered in China, followed by Japan (23 %), Germany (19 %) and Korea (11 %). In Taiwan, internship offers remained on a lower level whereas internship offers in South Asia have steadily grown. Korea has become one of the most active internship destinations within the last year.

This year, the KOPRA team continued to further improve and streamline processes in preparation for the expected end of Mercator Foundation support in early 2009. [Note: Fortunately, the foundation meanwhile extended its support, so that the project can be financed for approximately another year.] In Shanghai Office and in Seoul Office several team members represented KOPRA in place, while Tokyo Office and Taipei Office are currently run as virtual offices, orchestrated from Duisburg. Ms Caterina Wasmer has taken over as Director of Operations.

Current Issues of the Political Economies of Japan and Korea: Comparative Research

Funded by the Bertelsmann Foundation, 2009–2010

Werner Pascha is contributing to two projects of the Bertelsmann Foundation that promise stringent comparisons between various countries, based on a rigorous and detailed analytical framework. As for Japan, the framework is given by the “Sustainable Governance Indicators” project. It analyzes and compares the need for reform in OECD member countries, as well as their ability to respond to current social and political challenges. The project is designed to create a comprehensive data pool on government-related activities in the world’s developed, free-market democracies. With respect to South Korea, the framework is the “Comparative Crisis Management” project of Bertelsmann Foundation which intends to evaluate the capacities and abilities of the political management in selected developing and transition countries in response to the global financial and economic crisis.

WiMi-Care – Knowledge Transfer as Support for Influencing the Use of Micro-System Technologies in the Care Services Sector***Wissenstransfers für eine aktive Mitgestaltung des Pflegesektors durch Mikro-systemtechnik***

Developments in labor markets and demand for elderly care open an opportunity for innovations in the use of service robots in health services. Microelectronic innovations often proceed, however, without consideration of the needs of either care workers or elderly persons.

The project “WiMi-Care” involves a close partnership with the Fraunhofer Institute for Manufacturing Engineering and Automation (IPA) in Stuttgart, the developer of the Care-O-bot, a service robot aimed at the care services market, the Ludwigshurger MLR Systems GmbH für Materialfluss und Logistiksysteme, a developer of automated mobile systems, and Duisburg sociologists Diego Compagna (project direction), Kathrin Mauz and Stefan Derpmann. The aim of the Duisburg research is to highlight the importance of knowledge transfer between those who design service robots and the organizations and persons who use them. User design activities are supported by project partner User Interface Design (UID).

The research began in 2009 with an assessment of possible uses for robots and automated mobile systems at an elderly care facility, where in the next stage the Care-O-bot will be used for attending to needs of elderly patients. Duisburg researchers are especially interested in how knowledge gained from such tests are then taken up into the innovation and commercialization process. As such, the concerns of the Duisburg research go well beyond the issue of “usability” to understand how knowledge is generated at the front-line of service work and transferred back to engineers and commercial firms designing and marketing robots for service functions. The project aligns closely with a recent EU communication on technology and demographic change, and has taken on the role of an important pilot project for future technology policy in the German Education and Research Ministry program on “Technology/Services/Demography”. At the request of the BMBF program, the Duisburg researchers are exploring options to bring Japanese and German researchers in the field of service robotics into closer communication. Project participants participated in a number of conferences and published 15 working briefs, details of which are available on the project web site: www.wimi-care.de.

Focus Group on AAL and MST Technology of the User-Service Interface

At the request of the BMBF project administration, Karen Shire was named coordinator of a “focus group” composed of eight project consortiums awarded funding within the BMBF research program “Technology and Services in the Context of Demographic Changes”. The aim of such BMBF “focus groups” is to generate inputs into policy-making and future BMBF research programs, in this case, in relation to micro-systems-technology and demographic change. In an inaugural meeting of the focus group in June in Duisburg, participating researchers agreed to focus specifically on the user-interface, and to develop research collaborations and cross-learning between social scientists and engineers in developing technologies for service contexts. The focus group will cooperate with the German Institute for Japanese Studies (DIJ), Tokyo, and the Japan Foundation in Cologne, to improve the communication between technological innovations in carework in Japan and Germany.

Commissioned by EUROFER – European Confederation of Iron and Steel Industries.

The project is designed to examine the overall interaction between state and market forces in the Chinese steel industry and highlight the specific state-business nexus in China’s post central planning economy. This includes an analysis of the major policy programs designed to provide guidance to the steel industry and its stakeholders in management positions as well as government agencies at various levels. On the micro-level the study analyzes the specific policy tools and discretionary instruments by which Chinese government organizations are intervening in the micro-management of Chinese steel enterprises and direct industry development.

The project aims at gaining a better understanding of China's consumers' brand preferences, shopping habits and other parameters of their consumer lives. It is based on face-to-face interviews in more than 1 000 households in various Chinese cities. In 2008/09 the focus of research has been put on the attitudes and actual buying behavior of Chinese consumers vis-à-vis fake products.

Relational Corruption in the PR China – Institutional Foundations and Impact on Economic Development and Growth

Autonomous project embedded in the initiative "The (Dys-)Functionality of Corruption in Changing Contemporary Societies" of the university's five main research areas (Profilschwerpunkt) "Change of Contemporary Societies"

The Chinese economy has gone through three decades of rapid economic growth, while at the same time experiencing a dramatic increase in the incidence and intensity of corruption. This dual development gives rise to a paradox, as standard economic theory understands corruption as being detrimental to economic development. Against this background the project deals with the specific institutional foundations and the politico-economic environment of corruption in contemporary China.

Video Conferences with WUN on China

For the second time the Institute participated in virtual seminars on Contemporary China organized by the Worldwide Universities Network (WUN). Weekly video conferences allowed for virtual communication between universities in Australia, East Asia, Europe and the U.S. Thomas Heberer gave a lecture on "Is China Creating Civil Society Structures Top Down?", October 30, 2008.

Task Force Seminar (Advising the Federal Ministry for the Environment)

This seminar (winter semester 2008/09) approached current domains of environmental policies in China. The Task Force Seminar's participants should learn and practice policy advisement. External cooperation partner was the German Federal Ministry for the Environment, Nature Conservation and Nuclear Safety (BMU). The topics were elaborated by the students in cooperation with Representatives of the Ministry. The latter suggested specific topics in which they wanted to have policy advisement. In working groups the students worked out strategies for an environmentally friendly development in China, including the position of China in international environmental negotiations, biodiversity in China, financial incentives for the promotion of renewable energy, the implementation of environmental policies on the local level by the case study of water management, product responsibility and product safety as a societal demand with the options for consumer organization and articulation. Moreover, recommendations for the German-Chinese development cooperation were elaborated. At the end of the semester the findings of the students were presented at the ministry in Berlin. The seminar was organized and guided by Prof. Thomas Heberer and Anja-D. Senz.

Christian Göbel und Daniel Lambach leiten das Forschungsprojekt „Determinanten der Stabilität und Instabilität autoritärer Regime“ und widmen sich der übergreifenden Frage, wie lernfähig autoritäre Regime sind und welche Möglichkeiten ihnen zur Verfügung stehen, ihre Lebensdauer zu verlängern, auf Bedürfnisse der Bevölkerung zu reagieren und schließlich Legitimität zu generieren.

Der mit Mitteln des Profilschwerpunkts Gegenwartsgesellschaften im Wandel (Fachbereich Gesellschaftswissenschaften) geförderte Workshop brachte 15 führende Experten der Theorie und Praxis autoritären Regierens aus ganz Deutschland zusammen, die ihre Forschungsergebnisse präsentierten und über zukünftige Perspektiven der Autokratieforschung diskutierten. Der Workshop diente einer Bestandsaufnahme und Weiterentwicklung der Forschung zu diesem Thema, das sich zu einer zentralen Fragestellung der vergleichenden Politikwissenschaft entwickelt. Konzeptuell ausgerichtete Beiträge beschäftigten sich mit dem Stand und Perspektiven der Autokratieforschung, einem Konzept zur Analyse autoritärer Konsolidierung, der Beziehung zwischen Staat und Gesellschaft in autoritären Regimen sowie der Frage, ob und wie sich Anerkennung und Integration in die Staatenwelt umwandeln lassen in Legitimität in der eigenen Bevölkerung. Fallstudien, die sich diesen und angrenzenden Themen widmeten, wurden präsentiert zu China und Guinea, Russland und Venezuela, Algerien, Marokko und Tunesien, den Golfmonarchien sowie dem Sudan.

In der Darstellung und Diskussion bestehender Forschung wurde deutlich, dass einzelne Mechanismen der Stabilisierung autoritärer Herrschaft durchaus bekannt sind, in vielen

Bereichen aber noch Forschungsbedarf besteht, und übergreifende Forschungsansätze noch ganz fehlen. Der Workshop trug dazu bei, das Forschungsfeld zu systematisieren, neue Erkenntnisse zu integrieren, die Chancen und Risiken übergreifender Ansätze zu diskutieren und Kooperationsmöglichkeiten zwischen den Wissenschaftlern aufzuzeigen.

5th ECPR Panel: The (In-)Stability of Authoritarian Regimes

Theories of regime transformation are generally characterized by a teleological outlook that sees all regimes as verging towards democracy. Usually, such theories are formulated as phase models in which democratization is followed by a period of democratic consolidation.

Although several authoritarian regimes across the world have displayed remarkable stability, a corresponding concept of ‘authoritarian consolidation’ does not exist thus far. Thus, there is a need to join theoretical and empirical expertise and find ways to account for the stability of certain authoritarian regimes. The overarching questions addressed in the panel were: what are the internal and external factors that determine the survival of authoritarian regimes? Why has authoritarianism survived in some countries, but not in others? Are there different qualities to authoritarianism?

LIBRARY REPORT BIBLIOTHEKSBERICHT

The East Asian Studies collection comprises about 28,150 monographs and more than 200 periodicals as of Sept. 2009. All of these titles can be searched for electronically in the Online Public Access Catalogue (OPAC) of the Duisburg-Essen University Library (<https://katalog.ub.uni-duisburg-essen.de/F>) and also in the OPAC of the HBZ Network Catalogue, North Rhine-Westphalia (<http://okeanos-www.hbz-nrw.de/F>).

During the span of time this report relates to, we have received not only budgetary funds but also funds from the tuition fees as well as from the library and the faculty. These funds enabled us to acquire more educational titles and multiple copies. We have bought electronic journal articles as well. Approximately 350 titles have been added to the collection.

At the national level, the East Asian Studies Library continues working in association with CJK (Chinese, Japanese and Korean) libraries and a network of Japanese libraries in order to grant scientists and students fast access to other collections. Our scholars may use, for example, the direct library loan service offered by the Berlin State Library, East Asia Department, since the Institute of East Asian Studies has an agreement with the Berlin State Library, which also gives access to selected databases under license in the Virtual Library East- and Southeast Asia – CrossAsia (<http://crossasia.org>).

The East Asian Studies Library continues a joint project with other national libraries (Bonn, Düsseldorf, Trier) to accomplish cataloging Chinese and Japanese monographs, using the original characters as listed in the HBZ Network Catalogue, North Rhine-Westphalia, 2006.

At an international level, the East Asian Studies Library cooperates with the National Institute for Informatics (NII) and other Japanese libraries in Europe. The parallel cataloging of Japanese monographs has been continued, using the original characters as listed in NACSIS-CAT (Japanese Union Catalogue), hosted by NII. With the help of the Chinese and Japanese characters, approximately 4,300 of our titles can be searched for not only in Webcat (<http://webcat.nii.ac.jp>), but also in the European Union Catalogue of Japanese Books (<http://www.niicat.eu>).
